

RULES AND REGULATIONS OF THE ONLINE COMPETITION “EVERY PAST IS MY PAST” ORGANISED BY THE MUSEUM OF FINE ARTS

The title of the competition (hereinafter: Competition): Every Past is My Past

Organiser of the competition: Szépművészeti Múzeum [Museum of Fine Arts, Budapest] – Magyar Nemzeti Galéria [Hungarian National Gallery] (seat: 1146 Budapest, Dózsa György út 41), hereinafter referred to as the Organiser.

from now on jointly referred to as the Partners.

The Organiser and the Partners shall process all personal details provided in the Competition by the participants in accordance with regulation (EU) 2016/679 of the European Parliament and of the Council on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (GDPR).

1. Participation in the competition

The competition organised by the Organiser is exclusively open to resident private individuals, capable of acting, 18 years or older and not falling within the scope of individuals specified in point 11 below.

2. Duration of the competition

The competition will last from 12:00, 1 July 2019 to 24:00, 25 August 2019. Only answers sent in within the duration specified here will be considered in the competition. The answers sent in before the time specified as the start of the competition or those submitted after the time specified as the end will not be accepted by the Organiser as valid entries.

3. The process of the competition and the conditions of winning

Every individual (hereinafter: Player) who satisfies the criteria set out above in point 1, registers in the competition on the webpage of the competition (www.en.mng.hu/every-past-is-my-past-quiz) within the duration of the competition specified above and in the way set out below and provides correct answers to the five multiple choice questions asked there is entitled to participate in the competition.

One Player can only take part in the competition with one email address that is his or her own. In regard to the emails registered during the competition, the Organiser accepts no responsibility for any disputes arising from the unlawful use of the email or abuse committed using the email. The Organiser is not liable to check how many emails one Player uses during his or her participation in the competition, although if the Organiser discovers that one Player entered the competition with more than one email, it reserves the right to exclude the Player in question from the competition.

4. The prize and the process of the draw

The Organiser hereby declares that the competition it announced here does not fall under the legal scope of Act XXXIV of 1991 on gambling.

The Organiser will draw a total of three prizes among the participants after the closing time of the competition.

1st prize / main prize:

Exclusive city walk with Hosszúlépés for a group of 2-26 friends.

2nd prize / prize nr 2:

Dinner for two in the Gettó Gulyás to the tune of HUF 20,000

3rd prize / prize nr 3:

"Every Past is My Past" gift pack from the MuseumShop to the tune of HUF 15,000.

Extra prizes:

5 exhibition catalogues

3 winners can pick their favourite photo from the exhibition receive it printed and framed.

The prizes will be drawn among those participants who registered in the competition at any time within the full duration of the competition, i.e., between 12:00, 1 July 2019 and 24:00, 25 August 2019, and submitted correct answers to all the five questions of the competition.

The prize draw will be conducted with a machine; the time of the draw is 2 pm, 29 August 2019.

The location of the prize draw is 1014 Budapest, Szent György tér 2, which is the office of the Organiser.

The winners of the prize draw will be notified by email on the day following the draw at the latest, i.e., by 12:00, 6 September 2019. In the email notification the winners will be asked to confirm and provide the following personal data: name, address, telephone number.

The winners will have to agree with the Partners about the details linked to the use of the prizes (date, time of receipt, flight, booking of accommodation, etc.).

The Organiser will draw 2 main reserve winners in addition to the actual winner for each prize. The reserve winners will become entitled to the prize in the order of the draw, i.e., if the winners drawn first and then the reserve winners drawn before them forfeit or rescind their right to the prizes for any reason.

After the prizes are drawn, the winners are obliged to receive the prizes within seven (7) calendar days of being notified at any of the contact details provided and declare their intention to receive their prizes in accordance with the conditions specified. In the event a winner not wishing to receive the prize in the specified way or not declaring his or her intention of wishing to receive the prize, the reserve winner who comes next in line will be entitled to the prize. The Player must inform the Organiser about rescinding his or her right to receive the prize in writing and within the time period specified for the receipt of the prize.

5. Exclusion from the competition

Players can participate in the competition within the duration specified in point 2, provided they fully satisfy the requirements of the rules and regulations of the competition. Based on the requirements laid down in the rules and regulations of the competition, the Organiser will verify each winner and if he or she does not satisfy the requirements of the rules and regulations of the competition, it reserves the right to exclude the Player in question from the competition.

6. Resolution of disputes

Should any dispute arise in regard to the entitlement of any Player to any of the prizes, the Organiser's decision shall prevail.

8. Receipt of the prizes

Prizes can be received only after the personal details of the winners, specified in point 4 of this document of rules and regulations, are recorded and following the notification of the fact of winning, as follows: the prizes will be received in person at a time and place previously agreed upon but after the time of the use of the prize was agreed.

Should the Player entitled to receive the prize not appear to receive the prize within the period specified for such, the Organiser shall proceed in accordance with point 4.

9. Modifying personal details

The Organiser reserves the right to exclude Players who are not qualified to receive their prizes because of the data provided them being false or containing errors. The Organiser accepts no responsibility for any occurrence resulting from incorrect data provision by a Player. Players have the opportunity to exercise their right to correct data as stipulated by the GDPR within the 7-day period specified in point 4 of this document; in other words, Players can ask the Organiser to modify any data they provided wrongly.

10. Transferring prizes and financial consequences of the receipt of the prizes

The prizes can neither be transferred, nor converted into money. The winners are exempt from paying personal income tax after their prizes.

Any additional costs and expenses possibly arising from the receipt and use of the prizes are to be covered by the winners (e.g., the cost of travelling to the location where the prize is received, etc.)

11. Individuals excluded from participating in the competition:

- leading officials and employers working for the Organiser, as well as the agents of those involved in the present competition and their close relatives (point 1 of section (1) of article 8:1 of the Civil Code)
- other individuals directly involved in the implementation of the present competition and their close relatives.

12. Additional provisions

12.1. Neither the Organiser, nor any other company taking part in the competition takes responsibility for any erroneous/incomplete data provision that may have occurred during the data verification conducted by phone as part of the competition process; nor shall they be involved in correspondence in this matter. The Organiser undertakes no guarantee linked to the prizes.

12.2. The competition will be promoted on the website (www.en.mng.hu/every-past-is-my-past-quiz) and Facebook page of the Museum of Fine Arts, Budapest – Hungarian National Gallery, on the Facebook profile of Hosszúlépés. Járunk?, on the Facebook profile of Gettó Gulyás and on the Facebook page of the MuseumShop.

12.3. The Organiser has the right to check each entry in order to verify the due satisfaction of the requirements laid down by the rules and regulation herein; should any part of the entry or the Player who submitted it not meet these requirements, the Organiser can exclude the Player in question from the competition.

12.4. The Organiser accepts no responsibility for any incompleteness/error (e.g., misspelt name, email, etc.) or delay that may be notices or may occur for any reason in the case of the winners.

12.5. The Organiser accepts no responsibility whatsoever should any external, so-called SQL attack is launched against the website or the server that operates it. This means that if any Player receives an erroneous system notification in regard to prizes, their status of being a winner/not a winner, etc. as a result of an attack launched against the website or the server, the Organiser cannot be held liable.

12.6. The Organiser reserves the right to immediately exclude any Player from the competition if said Player manipulated (via computer) the competition, generated mass emails or demonstrated any behaviour that is contrary to the spirit of the game or inflicts damage upon it, or if reasonable suspicion of these events arises.

12.7. The Organiser accepts no responsibility whatsoever for any malfunctioning that may occur in the operation of the webpage for reasons outside its control and as a result of which the website does not function at all or can only be partially used; at the same time, the Organiser shall take all the necessary steps in its power to identify the source of the problem and find a solution to repair it as soon as possible.

12.8. By entering the competition, the Player accepts that the content, capacity, speed of messaging and transmission as well as its response time are dependent upon the technical parameters of the serving technology and therefore all the aforesaid can be negatively affected by factors outside the control of the Organiser such as (but not exclusively) a connection error, the capacity of the a server computers as well as the maintenance of a safe network connection. The Organiser accepts no responsibility that may result from what is mentioned in this paragraph, thus especially delays or failure in the forwarding and registration of entries and the use of the prizes as well as the overloading and shutdown of the system.

12.9. By entering the competition, Players acknowledge and understand all the conditions set out in the present rules and regulations. Should a Player have any complaint in regard to his or her data being processed, he or she can contact the Hungarian National Authority for Data Protection and the Freedom of Information or the competent Court. No other legal processes can be pursued in connection with this competition.
